2010 is the year of anniversaries. VSCDA is celebrating 25 years of racing at Road America and honoring the 60th anniversary of racing in Elkhart Lake. We are re-creating the 3 special cup races from 1950, the Elkhart Lake Cup, the Sheldon Cup and the Kimberly Cup. These races are for production cars and are free. The **important** thing here is that in order to run these races this form must be included with your entry form. Because these races combine groups, based on lap times, there may be duplicate numbers, so some of you will be assigned a different number for the extra race. (just like in the enduro) This takes a lot of work to set up the grids for timing and scoring therefore early entry will be appreciated. **Important**, below is the preliminary breakdown of how you will be grouped for the cup races. Some of you will easily know which cup race you will fall into. Some will not. Sign up for the cup race that you will most likely fit into. Those of you that will be placed in a particular cup race strictly on lap times will be placed according to your Saturday morning qualifying session. Final grid entries will be posted Sunday morning in the VSCDA tent. You must verify the cup race you will be in and the number **that must** be on your car.

Open wheel cars, don't feel left out. There is an extra race for you on Sunday too!
